

Club Meeting Minutes March 17, 2016 Audrain Courthouse Conference Room

Meeting was called to order by President Ron Hutsel WB0JAE.

Treasurer's Report was submitted and accepted.

Ron asked for any old business that needed to be discussed.

- Mike WBOIXS asked about gravel for the tower site. Mike talked to Steve Shaw about the use of a county truck to haul and the county declined. Mike also suggested that we hire someone to haul it. The gravel will cost \$165 for 15 tons, and to have it hauled would be \$225 total for 15 tons.

- Discussion was opened up about the possibility of announcing neighboring nets on our repeater by putting it on our announcement machine a few hours before their net as a reminder.

 - Mike WBOIXS, Ron WBOJAE and Bill KCOACS will check with a few clubs to see if they are interested.
- Jeff opened up discussion on adding more Allstar equipment to link the 2 meter with the 440 machine when it goes on the air. Jeff KD0QCN made a motion to get all the equipment needed, Bill KC0ACS gave a second, the motion was voted on and approved.
- Kenny KE0DUO opened the floor for discussion on Filed Day.
 - Ron WB0JAE suggested that we setup an operation schedule and let everyone sign up for a shift that they will be responsible for.
 - It was also decided that we should setup at a more public place. Mike WBOIXS will
 check with the City of Mexico to see what parks are available for us to use, with a
 preference being for Lakeview.

- o Ron WB0JAE opened the floor for nominations of Field Day Committee Chairman.
 - Nominations of Kenny KEODUO and Mike WBOGOA were given, it was decided that Kenny and Mike will co-chair with Dick K2HT elmering. Board voted to elect as proposed.

Bill KCOACS made a motion to adjourn the meeting, and Bill NOON gave a second. Meeting was adjourned.
